South Carolina Department of Mental Health

- The new hire from October 2021 resigned and we are in the process of recruiting for this position again. Existing staff are working together to work this position until we successfully recruit a new MHP.
- Midlands FRST flyers and outreach have been completed by 8 police departments, towns, and EMS.
- A referral form was developed by the Uplift team and is currently being used by ED staff.
- Community visits have been initiated and shared protocols are in place.
- Crisis Intervention Training, CIT, is being completed by LCCMHC staff thanks to Town of Lexington PD.

Readiness and Partnership Transformation

221 individuals completed the Uplift Readiness Assessment - a 142% increase from last time! They spanned five types of providers (medical, law enforcement, first responders, mental health, and other providers). Over half of the participants had some prior knowledge of Uplift. A common challenge includes the complexity of assisting people with behavioral health issues in an effective manner, as well as limited staff. Reported strengths show a shared belief that organizations are using the most effective techniques in helping people with behavioral health issues. Work and organizational culture was also noted to be a key strength. Growth has been seen in every measured domain including working together, being strategic, and having a shared vision. Since current goals were all met or nearly met, new goals were set.

Mental Health First Aid

- 9 Uplift members attended MHFA hosted by LRADAC.
- Trained to recognize a mental health crisis and how to temporarily handle the situation.
- Participants were given Deterra Drug Disposal System, fentanyl test strips, and 4 units of Narcan.






Subcommittee Updates
